Retail Banking Loans

Commission for issuing a discharge letter / outstanding indebtedness balance letter

EGP 100 per letter for all types of secured/ unsecured personal cash loans.

EGP 25 per letter for other retail banking products and loans.

Unsecured personal cash loan

Administrative fees

2% of the loan value with a minimum of EGP 250 till 7 years paid one time in advance.

Late payment fees

3% of the loan value with a minimum of EGP 250 more than 7 years paid one time in advance.

Early settlement fees (partial/ full)

7% of the paid amount in cash / or by transfer/ or by any other repayment tool.
12% in case of other bank buyout.

Life and total disability insurance

Free

Personal cash loan against cash collaterals

Administrative fees

1% paid one time in advance.

Late payment fees	2% of the due amount .
Early settlement fees (partial/ full)	3%
Stamp duty fees	Deducted from the administrative fees.

Auto Loan

Administrative fees	1.5% up to 5 years and 2% up to 6 and 7 years without a minimum or a maximum
Early settlement fees (full)	3% of the outstanding loan balance till 5 years, and 3.5% for more than 5 years
Early settlement fees (partial)	3% of the prepaid amount for loans till 5 years, and 3.5% for more than 5 years
Late charge	2% of the due amount
Loan account maintenance fees	Free
I-score fees	Free

Auto Loan against collaterals
